DETAILS OF THIS INVESTIGATION:

On Wednesday, 25 May. 88, Reporting Officer MICHAEL HOCH (#525) went to The TWIN TOWERS, 2900 Farnam Street, and spoke with the Owner/Operator of The TWIN TOWER complex, MIKE CUTLER. Reporting Officer had previously spoken with MIKE CUTLER and stated that his purpose was to do a follow-up interview concerning LARRY KING, who was mentioned in the initial interview.

MIKE CUTLER indicated that a party by the name of RUSTY NELSON, who is occupying Apt. #3-B (which was leased to LARRY KING), has since moved out of the apartment complex. CUTLER believed the 14th of May to be the date that NELSON left.

LARRY KING rented Apt. #3-B on the 2nd of February, 1988; at which time, a THOMAS VARASTIC (who is a white male, possibly an attorney) moved into this apartment. This apartment rents for \$595.00-a-month, and KING would pay this fee on a monthly basis. KING also stated his intentions to CUTLER that he was going to keep renting the apartment through June.

A JOYCE MINNICK, who is a housekeeper in The TWIN TOWERS Building, works for KING, cleaning both of his apartments - being Apt. #3-B and the Penthouse apartment, which he currently is also renting. Housekeeper MINNICK also works for various other individuals in the complex.

In August of 1987, KING initially started renting one of the Penthouse apartments in The TWIN TOWERS for \$1,400.00-a-month on a three-month-lease purchase agreement. After the three-months were concluded, KING had made no preparations to actually the apartment or condominium for a price of \$248,000.00.

Approximately one week ago, CUTLER showed the apartment to a prospective buyer; at which time, KING appeared to be somewhat upset and indicated that he was planning on buying the apartment, and that he would be coming into some money with which to purchase the apartment in the very near future.

Since KING has rented the apartment, MIKE CUTLER believed that he has possibly put \$50,000.00 into the apartment in such things as decorating, drapes, and furnishings. CUTLER went on to state that he had bought a couch from one of the furniture dealers in Omaha that would not fit in the elevator as it was being transported to KING'S apartment. And, as a result of this, a crane was rented for the amount of \$1,200.00 to have the couch lifted to the apartment from the outside.

MIKE CUTLER also stated that the apartment was very elegantly furnished; and the \$50,000.00-outlay would not include (what he described as) original paintings, along with what is believed to be possibly a solid silver chair.

CUTLER also stated that there are three parking places leased with the Penthouse in the underground parking/or storage area. And that he knows that KING drives at least five different vehicles: Three of the vehicles being Mercedes-Benzes, one being a Cadillac Alante, and the other being some type of sports car.

He also knows that KING spends a lot of time out of the country, as he has called KING about business and has been advised that KING is either out of the country or has talked to KING personally who has stated that he is going out of the country or has been out of the country. CUTLER believes that KING'S wife is from Jamaica, and that KING makes several trips to the Caribbean area.

CUTLER also stated that he believes that KING owns properties in Washington, D.C., which possibly is an old Brazilian embassy, and also property in the Caribbean.

CUTLER went on to state that KING has a habit of throwing names around, and it is believed he is very influential in the Republican party. CUTLER also indicated that he does not understand how KING has as much money as he does to spend. KING does not actually live at the Penthouse apartment in The TWIN TOWERS, but uses the apartment for parties and occasionally stays at the apartment, apparently.

CUTLER stated that he had talked to a realtor (whose name he could not recall), who indicated that KING apparently attempted to purchase a residence approximately five years ago and, at that time, had trouble coming up with a down payment for the house. It seemed strange to CUTLER that in five years KING has come into as much money as he spends.
